All school improvement activities at Bingham High School are based on the school improvement plan which focuses on student learning, teacher instruction and instructional improvement activities. In addition, we are focusing on the improved use of technology as learning, instruction, and communication delivery systems. Bingham High School is working to aggressively address the needs of at-risk students through individual attention provided through the study skills class which is being funded through Land Trust funds. The school is also actively addressing our critical need to update and expand our technology so that students can take advantage of the opportunities improved technology provides. Land Trust money is being utilized to pay for the teachers and support staff, along with the actual technology being purchased. To this end, Utah Land Trust money is being used for the salary of a technology specialist and professional development for faculty and staff.

- Evaluate by tracking individual student, school, district, state, and national test scores.
